

Personal Data Collection, Processing, and Use Consent Form

This consent form details how National Chung Cheng University (NCC) will handle the personal data collected from students.

By checking “I Agree” and signing this consent form, you acknowledge that you have read, understood, and agreed to all the terms herein and any subsequent amendments. If you are under the age of 18, your legal guardian must read, understand, and agree to all the content of this consent form and its subsequent amendments before you may use this service. If you proceed to use this service, you indicate that you have obtained your legal guardian’s consent and that you will comply with all the following terms.

I. Basic Personal Data Collection, Updates, and Storage

1. NCC collects, processes, and uses your personal data in accordance with the Personal Data Protection Act of the Republic of China, related laws, and NCC’s Privacy Policy Statement.
2. You (or your team) must provide accurate, current, and complete personal data at the time of application.
3. NCC collects your personal data in the course of conducting its business operations.
4. If any changes are made to your personal data, you must request a correction from NCC to ensure the information remains accurate, current, and complete.
5. If you provide incorrect, false, outdated, incomplete, or misleading data, you may lose your relevant rights and benefits.
6. In accordance with the Personal Data Protection Act of the Republic of China, you may exercise the following rights with regard to your personal data:
(1) The right to inquire into or review your personal data. (2) The right to request a copy of your personal data. (3) The right to request to supplement or correct your personal data. (4) The right to request NCC to cease collection, processing, or use of your personal data. (5) The right to request the deletion of your personal data.

NCC may refuse requests to cease collecting and using your personal data if it is necessary for the performance of its duties or operations. If you wish to exercise the rights stipulated in Article 6, please refer to the contact information for personal data protection listed in NCC’s Privacy Policy Statement to contact NCC. NCC shall not be held liable for any damages to your rights or interests resulting from your exercise of the rights stipulated in Article 6.

II. Purpose of Collecting Personal Data

1. NCC collects your personal data for personnel management, education, and administrative purposes (e.g., event coordination and prize distribution).
2. Collected personal data: name, phone number, e-mail, school/department, and student ID number.
3. If the use of your personal data differs from the original purpose for which it was collected, NCC will obtain your written consent before such use. You may refuse to provide your personal data to NCC, but doing so may result in the loss of your rights or interests.
4. The period during which NCC may use your personal data begins on the date of collection and ends the purpose for which it was collected no longer exists or the period during which it may be legally retained ends. The region of use shall be limited to Taiwan.

III. Confidentiality of Basic Information

Your personal data are protected and governed in accordance with NCC's Privacy Policy Statement. If NCC violates the provisions of the Personal Data Protection Act, or if your personal data are stolen, leaked, altered, or otherwise compromised by natural disasters, incidents, or other force majeure, NCC will notify you through appropriate means—by phone, letter, e-mail, or a website announcement —upon verification of the incidents.

IV. Consent Form Validity

1. By checking "I Agree" and signing this consent form, you indicate that you have read, understood, and agreed to all the terms herein. If you violate any of the following terms, NCC reserves the right to terminate all benefits, interests, or services provided to you at any time.
2. NCC reserves the right to amend the terms of this consent form at any time. Amendments will be announced on NCC's website, and no individual notifications will be provided. If you do not agree with the amendments, you must stop using this service. Your continued use of this service indicates your agreement to be bound by the amended or added content.
3. Written or verbal advice or information obtained on the basis of this consent form shall not constitute any guarantee beyond the terms expressly stated in this consent form.

V. Governing Laws and Court of Jurisdiction

The interpretation and application of this consent form and any disputes arising therefrom shall be governed by the laws of the Republic of China, with the Taiwan Chiayi District Court serving as the court of jurisdiction.
